Stained Glass Window Restoration:

- + We have received \$6,450.00 to restore one of the three windows that were discovered during the tuckpointing of the Church in September. The windows were removed by Jacksonville Art Glass in November and taken to their Glass Studio in Jacksonville for storage and future restoration. Together the three windows depict the crucifixion of Jesus found in the Gospel of John, chapter 19, verses 26-27.
- ⁺ Of the three windows we have received a pledge from Holy Family Parishioners in the amount of \$14,800 to pay for the restoration of the large window that depicts the crucified Jesus on the cross on Calvary. The other two windows are The Blessed Virgin Mary (still in need of a pledge in order to complete the restoration of this window) and the Apostle, St. John (received \$6,450.00 from a Holy Family Parishioner) at the foot of the cross.
