<u>Phase II, Approved Project(s) Awaiting Contract and Insurance Documents:</u> The financial resources are in place, the Finance Council has approved the hiring of a contractor and the Pastor has approved the project. The Contractor has been contacted and the Parish is awaiting the contractor's formal contract and insurance papers.

**Phase III, Contract(s) forwarded to the Diocese**: The contractor's formal contract and their insurance papers have been forwarded with a formal request for resolution to the Diocese for final legal and insurance reviews.

**Phase IV, Contract(s) has been Awarded**: The Parish has received final approval to sign the formal contract from the Diocese. The Pastor has signed the contract and the contractor has been notified.

<u>Phase V, Restoration/Repair/Construction</u>: The contractor has provided an approximate start date to the Parish for the restoration/repair/construction work.
