Explanation

<u>Projects Pending Approval</u>: These projects are currently awaiting additional engineer/design work, funding and the Finance Council's approval to spend the funds to hire a contractor.

Approved Projects Awaiting Contract and Insurance Documents: The financial resources are in place, the Finance Council has approved the hiring of a contractor and the Pastor has approved the project. The Contractor has been contacted and the Parish is awaiting the contractor's Formal Contract and Insurance Papers.

<u>Contract forwarded to the Diocese</u>: The contractor's Formal Contract and their Insurance Papers have been forwarded with a Formal Request for Resolution to the Diocese for Final Legal and Insurance Reviews.

Contract has been Awarded: The Parish has received final approval to sign the Formal Contract from the Diocese. The Pastor has signed the contract and the contractor has been notified.

Restoration/Repair/Construction: The contractor has provided a timeline to the Parish and has begun restoration/repair/construction work.

Project Review: Throughout the project there will be periodic reviews conducted by the Parish with the Contractor to ensure the work that is being done is in accordance with the approved contract.

<u>Project Closeout</u>: The work on the project has been completed to the satisfaction of the Parish and final payment has been made to the contractor

The combined maximum amount for the Capital Campaign is \$1,150,000.00.

Note 1. The amount for interior restoration may increase or decrease based on the dollar amount of pledges received and/or unanticipated expenses associated with the approved projects.

Note 2. All contracts are forwarded to the Diocese for legal and insurance reviews before they can be awarded.
