Phase I, Project(s) Pending Approval: These projects are currently awaiting additional engineer/design work, funding and the Finance Council's approval to spend the funds to hire a contractor.

The Contractor has been contacted and the Parish is awaiting the contractor's formal contract and insurance papers.
